International Speakers



DR KARI PIHLMAN DDS

Dr Pihlman received his Dental Licentiate in Dentistry, University of Helsinki, Finland in 1979. He then worked as a private Dentist at Läkkitori Dental Clinic, Espoo where he is the principal partner; He consults part time at the Implantcenter, Espoo; Nordic Dentists Ltd. Dr Pihlman was also the Laboratory Supervisor (locum post) at Department of Bacteriology and Immunology, University of Helsinki, 1979-1986.

Dr Pihlman was Clinical Teacher, MSc Program of Restorative Dentistry for International Postgraduates Institute of Oral Health, University of Helsinki 1997-2001 and is a Lecturer on restorative materials and bonding techniques (ceramic, composite and G-I), in Finland, Baltic, Central Europe and South Africa from 1988. He is an ISCD-certified international CEREC 3 Trainer 2002 (Berlin), CEREC 3 D Trainer 2003 (Sydney), 2004 (Orlando) and 2006 (Berlin) and a Member of Scandinavian Support Group of Stick Tech Ltd (glass fibre reinforcement in restorative dentistry).

Dr Pihlman is a co-operator in material testing to BISCO, Dentsply/Detrey, GC Europe, Espe 3M, Heraeus Kulzer, KerrHawe and Ivoclar Vivadent and a Member of Finnish Dental Association and Affiliate Member of ADA. Dr Pihlman has published scientific articles in the field of immunodermatology and aesthetic dentistry.

PROF DENIS KINANE BDS PhD

Prof Denis Kinane is a professor in the Department of Periodontics, Endodontics and Dental Hygiene in the University of Louisville School of Dentistry. He also serves as Associate Dean for Research and Enterprise and Director of the Oral Health and Systemic Disease Research Group.

His research focuses on periodontal immune and inflammatory processes, mainly explaining the causes, development and susceptibility markers of periodontal disease. Prof Kinane and his team also are examining the clinical relationship between oral and systemic health and diseases such as diabetes, cardiovascular disease and periodontal disease. Prof Kinane was chair of the International Society for the Prevention of Tobacco Induced Diseases in 2005 and hosted the International Smoking Cessation aspects, including NRT therapy specifically of the ISPT conference in 2004 in Louisville Kentucky. This conference was awarded an NCI grant and involved notable researchers from Hong Kong and USA on smoking cessation techniques and their impacts on oral health and systemic disease. Prof Kinane was an invited lecturer at the ISPTID meetings in Athens 2005 and Hong Kong in 2006.



Prof Kinane has received many awards for his work and has published more than 180 original articles in scientific journals and is the president elect of the Gordon Conference in Periodontology. He is the councillor for the Periodontal Research Group of the IADR and chairs and organises multiple symposia and international meetings.

Speakers

DR ALEX FORREST BDS_c, GCEd



Dr Alex Forrest is a Forensic Odontologist. He has a strong interest in anatomy, and this combined naturally with dentistry to lead him into the field of forensics. He has a special interest in the analysis of bite marks, and in applying digital techniques to the analysis of evidence. Dr Forrest has worked with both prosecution and defence and has given expert evidence at all levels of Queensland Courts. He has spent time in Thailand helping with the international victim identification effort following the South Asian tsunami in 2004, and in Bali helping identify victims of the 2002 terrorist bombing. He now works as a Consultant Forensic Dentist for Queensland Health and at Griffith University's Forensic Science Research and Innovation Centre.

MRS MARINA FULCHER

Mrs Marina Fulcher, a Fellow of AAPM, has managed dental, radiology, mixed allied health, community mental health, specialist practices and a large 52 practitioner multi-specialist practice. Nationally, Mrs Fulcher has been a member of the Member Focus Committee and chaired the Learning and Growth Committee. She was elected as a NSW National Board representative in 2005, Vice President in 2006/07 and President in 2007. Mrs Fulcher has a Diploma in Practice Management, Diploma in Management and Leadership, OND Business Studies and was one of the first students in Australia to complete the Cert IV in Training and Assessment. She has her own practice management business and works as a trainer for a practice management software company, giving her exposure to the challenges of working in many different practice types, both privately owned and in the NSW state hospital system.



DR MICHAEL MANDIKOS BDS_c (Hons), MS (New York), Cert Pros, FRACDS



Dr Michael Mandikos received his BDS_c (First Class Hons) from UQ School of Dentistry. He graduated from State University of New York with a Cert in Prosthodontics and Masters Degree in Biomaterials. He has researched direct and indirect composite resins and published scientific papers in Australian and international journals. Dr Mandikos is a member of ADA, a Fellow of the Royal Australasian College of Dental Surgeons and a recipient of the College Medal for highest examination results. Dr Mandikos holds appointments as a Visiting Specialist at the UQ School of Dentistry and is a Consultant Prosthodontist to the RAAF, and was a Visiting Prosthodontist to the Australian Army. He provides CPE courses for Dental Study Groups in Prosthodontics and Aesthetic/Cosmetic Dentistry and lectures in Australia and SE Asia. Dr Mandikos is a Reviewer for the Australian Dental Journal and others. Dr Mandikos maintains a private practice in Brisbane.

DR NEIL SAVAGE BDS_c, MDSc, PhD, FFOP(RCPA), FICD

Dr Neil Savage is a specialist Oral Pathologist and a Foundation Fellow of the Faculty of Oral Pathology within the Royal College of Pathologists of Australasia. He is an active member of the International Association of Oral Pathologists and Chaired the 13th International Congress on Oral Pathology and Medicine held recently in Brisbane. He conducts a private specialist practice in Oral Medicine and has been active in histopathology reporting for over 25 years. As well as conducting a specialist private practice Dr Savage is Reader in Oral Pathology and Oral Medicine at the UQ School of Dentistry, Consultant in Oral Pathology and Oral Medicine to the Royal Brisbane and Womens Hospital and Consultant in Oral Pathology to Queensland Medical Laboratories.

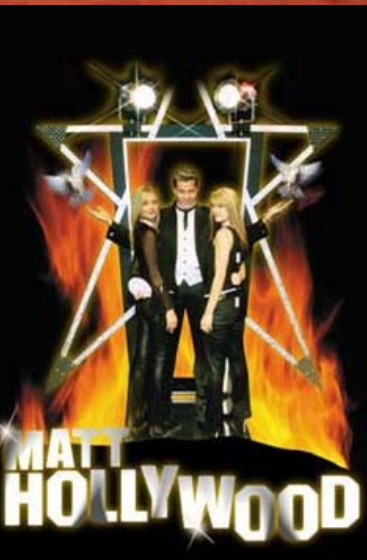
